1. CALL TO ORDER:

She will ask Jones Ford to bring some of their antique cars up to Yarnell for this. We are also hoping for a pallet of water from a corporate sponsor.

The Christmas Dinner for YFD will be on December 12 at 5PM. This will not be catered as the YFA plans to make all the food. This may cost about \$300 for 60 people. YFA is asking us to contribute for this. Richard moved that we provide \$150 for this from Grants and Donations. Carole seconded. All approved this.

We may also be able to sell patches, cookies and homemade dog biscuits at the Antique Car Show.
