1. CALL TO ORDER:

3. Approval of Draft Minutes:

A. Richard made a motion to approve the minutes for the YFD Regular Session of June , 15, 2020 . Dale seconded. Motion carried by all.

A. Chairman's Report: Denise provided a new roster with Board of Directors , Pension/Relief Board and Auxiliary Board- updated phone numbers.

Carole made a motion to accept 13 transfers as reported. Dale seconded. Motion carried by all. For special transfer, Carole made a motion to accept this transfer as reported. Richard seconded. Motion carried by all.

D. Chief's Report: (See Attached) Corey, Jordan and Brittany represented YFD on four wildfires. So far, wildland fires have brought in \$75,000 in revenue for our tender and ambulance use . EMT training will begin Aug. 29 and continue through Jan.9. Cadet program will resume in October. Virtual Memorial Run brought in \$10,200 including cash donations to the Auxiliary. Fuels project is complete in the Peeples Valley and Wihoit area. We will apply for our own project here in Yarnell in the next funding cycle.

We responded to 28 incidents including 19 EMS, 1 Motor vehicle accident, 1 truck fire, 2 Park rescues and 4 public assists.

Devin Carvalho will be hired as Full Time Captain.

E. Grant Report and Safer Report by Denise Roggio (see attached)

We have received VFA Wildland supplies. This grant was awarded May 2. We are at the end of 2 years of our Safer Grant next October. Less grants my be available in the future due to COVID.

5. OLD BUSINESS:

A. We received a letter from YWIA June27 regarding our existing agreement and issue of renegotiation. We have not yet had a meeting between us. We will call our attorney to see where we stand. Whether the 2016 letter of understanding is binding. Issue of renegotiation.

B. USDA update discussed by Denise. We have not yet received all of the funds.

C. Dale provided a Memorandum of Understanding and Proposed Agreement with Wickenburg Community Hospital and PVFD for us to read. We already have a Mutual Agreement with WCC, also Del Webb Hospital. We will stand by our existing Memo of Understanding.

6. NEW BUSINESS :

A. We were provided with a rate agreement for use of our Tender and Ambulance in wildfires. Both are rated at \$2,888/day with appropriate 2 person staffing. (See attached).

B. We approved changes in our Credit Card Usage #0019 YFD Board Policy. This new policy statement will be approved at our next Regular Meeting.
