We will send personnel to Wickenburg Police Dept for fingerprints, Personnel will bring this sealed envelope back to us. We will add a check and send all to DPS. DPS will return it to us if OK, after which it will be destroyed.

Chief will complete Advanced EMT training which is paid for by our SAFER GRANT funds.

Computer/Technology Upgrades with be completed with grant funding.

There were 13 calls in the last month- 2 accidents, 1 fire, 10 EMS.
